Conditions

1. We reserve the right to inspect equipment covered, before accepting this agreement.
2. This agreement is void if the buyer permits any persons other than our employees to render service to the equipment except as instructed by us.
3. Prices quoted refer to domestic type heating equipment only.
4. This agreement does not cover parts damaged by water, fire, act of God, accident, tampering or abuse.
5. Our obligation to furnish any parts is subject to their availability through normal sources of supply.
6. This agreement includes only repair and replacement of parts specifically listed which are defective due to normal wear.
7. This agreement does not include equipment failures resulting from customer's refusal of automatic delivery.
8. This agreement does not cover liability for injury or damage resulting from defects in, or the operation or non-operation, of customer's burner or its appurtenances or any other equipment, nor does it cover liability for loss or damage resulting from delay or failure to perform hereunder due wholly or partially to labor distur-

bances, fires, lack of material, governmental regulations, or any causes beyond our control.

9. Effective date of this agreement, shall be the date on customer's invoice.
10. During the contract period all fuel must be furnished by Gottier Fuel Co.. Delivery by anyone other than Gottier Fuel Co. terminates the service plan.
11. Account must be current. No balance over 30 days. Budget payments current.
12. **COMBINATION: OIL-WOOD or COAL** are not covered on this plan.
13. **ANY WOOD STOVE** which is connected to boiler/furnace smoke pipe, must be inspected by us for service plan coverage.
14. This agreement contains the entire agreement of the parties hereto and there are no promises, terms, conditions or obligations other than printed herein.
15. **THRU THE WALL POWERVENT** is not covered on service plan.
